

## What's In the SSAC for You?

### Informal SSAC

As an Informal SSAC you are:

1. A group or association, whether of legal status or not, that holds an informal (information only) relationship to the SnowStar Institute.
2. In receipt of SnowStar promotional mailings such as: Conference Information, Book Sales, or Announcements of Interest.
3. In receipt of the SnowStar magazine (AXIAL) and Newsletter (In The Meantime) for one year free of charge, and may continue for a second year at 50% off. Thereafter the regular Institutional Fee for these services will apply.
4. Entitled, as members of the Informal SSAC, to a friend of SnowStar discount rate on selected SnowStar events or products.

### Intentional SSAC

As an Intentional SSAC you are:

1. A group or association established specifically in the name and in direct relationship to the SnowStar Institute of Religion and whose leaders are SnowStar members in good standing.
2. In receipt of SnowStar promotional mailings such as: Conference Information, Book Sales, or Announcements of Interest.
3. Listed in AXIAL and on the SnowStar website as a SSAC community, including contact information and short, promotional announcements about any SnowStar related activities or event the group pursues.
4. Entitled to one free E-mail address specific to your SSAC with the SnowStar Institute (for example, [name\\_of\\_ssac@snowstarinstitute.org](mailto:name_of_ssac@snowstarinstitute.org)). The specific name must be approved by the SIR Webmaster.
5. Entitled to a *Bulk Membership Discount* of 10%. This means that all SIR members of the SSAC (provided they agree to receive their AXIALs, Meantimes, and other materials at the same address) can receive a 10% discount on their annual membership fees.
6. Entitled, in the case of non-SnowStar members involved in the Intentional SSAC, to a friend of SnowStar discounted rate on selected SnowStar events or products (SnowStar members get the member's discount on all items or events by default).
7. Agree to pay an annual \$25.00 SSAC registration fee, i.e., one fee for the whole group.

*Unique to an Intentional SSAC:* An Intentional SSAC is recognized and promoted as a Chapter of the SnowStar Institute.

### Institutional SSAC

As an Institutional SSAC you are:

1. A legally established organization, business, or community.
2. In receipt of SnowStar promotional mailings such as: Conference Information, Book Sales, or Announcements of Interest.
3. In receipt of the SnowStar Magazine AXIAL and newsletter In The Meantime.
4. Included in AXIAL and on the SnowStar website as an Institutional SSAC community, including contact information and short, promotional announcements about any activities or events your Institution may pursue (subject to reasonable limitations and appropriate consistency with the Mandate of the SnowStar Institute).
5. Entitled, as members of an Institutional SSAC, to a discounted rate on selected SnowStar events or products.
6. Agree to pay an annual \$55.00 Institutional Fee.

*Unique to an Institutional SSAC:* You must include with your application an enabling motion (to the effect that you agree to be an Institutional SSAC) from the board or governing body of
